SUMMER SCHOOL REGULATIONS - SUPPORT SERVICES  
SPEECH/LANGUAGE/HEARING/VISUAL IMPAIRMENT SPECIALISTS, ORIENTATION &  
MOBILITY, NURSES

SUMMER SCHOOL REGULATIONS

1. The full daily rate for employees shall be based on four (4) periods per day, for actual hours and days worked. The summer school daily rate of pay shall be paid for the days school is in session and the legal holiday of July 4.
2. With prior approval of the immediate supervisor, personnel assigned to summer work experience, only, may work a maximum of eight (8) hours per day provided an average of at least twenty-five (25) different students per hour are enrolled in the program.
3. Summer school assignments shall first be made available to employees covered by this Agreement for classifications included in the unit as specified in Article 1 - Recognition, of this Agreement.
4. Newly developed classes or programs created by unit members or by the District that relate directly to services performed by unit members, shall first be made available to unit members covered by the Agreement.
