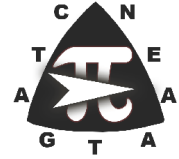

Re: Declaration of Candidacy - NEA Representative Assembly

This year the NEA Representative Assembly will be held in **Chicago, Illinois**. Delegates will need to arrive on **Friday, July 2, 2022** and will depart on **Thursday, July 7, 2022**.

NEA RA subject to change to virtual attendance in accordance to current COVID-19 pandemic

The NEA Constitution provides for the allocation of delegate credentials to local affiliates as follows: Locals with 75 or more members will be allocated delegates in the ratio of one delegate for each 150 NEA active members or major fraction thereof. **The GTA Board of Directors has decided to fund 8 delegates this year.** Each delegate will be allotted funds for transportation, lodging, and food which will cover the expenses incurred.

Any NEA member may be a local delegate candidate by filing a Declaration of Candidacy form with the GTA office at 3233 N. Verdugo Road, Glendale, CA 91208 **no later than 4:30 p.m. on Friday, February 18, 2022.** There is a Declaration of Candidacy form on the reverse side of this letter.

DUTIES OF THE DELEGATE TO THE NEA REPRESENTATIVE ASSEMBLY

1. Each delegate will be expected to attend all caucuses of the California delegation. Normally the caucus begins at 7:00 a.m. daily. Delegates must be registered with the California delegation to participate in the caucus.
3. Each delegate shall attend all business meetings of the R.A.
4. Each delegate is strongly encouraged to attend NEA Budget Committee Hearings, Resolutions Committee Hearings, By-Law Committee Hearings, speeches by prominent national figures, etc.
5. Each delegate should take into consideration CTA State Council and caucus policy when voting.
6. Each delegate is encouraged to participate fully in all activities of the California delegation.
7. Each delegate, state and local, will be expected to sit with his or her Service Center Council delegation on the R.A. floor. This is to ensure communication regarding R.A. business and/or personal emergency information of concern to the delegate, as well as to verify attendance.

I understand that, as a local delegate, my attendance is being directly funded by membership dues. I accept my responsibility to carry out the above specified duties. I agree that should I have an unexcused absence* from the NEA/RA floor while business is being conducted, I will pay back to GTA that day's hotel cost and food stipend.

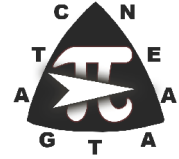
